



Treasurer's Report

The audited Financial Statements for the fiscal year ending March 31, 2016 are presented in the Annual Report. For the fiscal year 2015/2016 our auditors, Grant Thornton, Chartered Professional Accountants, and Licensed Public Accountants prepared the financial statements to comply with Canadian accounting standards for not-for-profit organizations.

Financial Operations

This was a year of financial challenge for United Way Greater Simcoe County. As announced last year the organization is transitioning to a three-year model of resource development. Unfortunately, our first year net campaign of \$1,516,562 was below expectation. The pressure in local fundraising was coupled with a historical liability arising from the Government of Canada Workplace Charitable Campaign, a contractual commitment through the United Way national office. While United Way Greater Simcoe County was able to partially offset these shortfalls by growth in our social enterprise activities, revenue over expenses fell short this year, by \$169,905. The results require the organization to intensify its resource development activities in the remaining years of the multi-year cycle and these efforts are already under way.

During the year we made provisions to support our Partner Agencies with \$807,055 in funding.

The organization also administered \$5,575,220 in third-party grants for various utility and community programs.

Financial Position

United Way Greater Simcoe County retains healthy liquidity with its cash and cash equivalents at \$1,157,756. Our net asset position remains positive as we redistributed reserves to deliver the growth strategy of a new fundraising model, and introduce new partnership investments in our communities.

On behalf of the Finance Committee of the United Way Greater Simcoe County, I would like to thank United Way finance team and our audit firm, Grant Thornton, for their efforts to present the financial statements for the year ended March 31, 2016.
